- I agree to indemnify Stripe, its affiliates, and their respective employees and agents (each a “Stripe Entity”) against any claim, suit, demand, loss, liability, damage, action, or proceeding (each, a “Claim”) brought by a third party against a Stripe Entity in connection with (i) the removal of the good(s) or service(s) identified in this notice, or (ii) the termination of the Stripe Service for the business(es) selling such good(s) or service(s); and
